**ORDER**

On February 1, 2022, the parties, by counsel, appeared on the Demurrer of Defendants Anthem Health Plans of Virginia, Inc., d/b/a Anthem Blue Cross Blue Shield in Virginia, and Healthkeepers, Inc. (collectively, "Anthem") to Plaintiffs' Amended Complaint.

Based on the parties' pleadings and the arguments of counsel, and for the reasons stated on the record, which are incorporated herein, it is hereby ORDERED as follows:

1. Anthem's Demurrer to Count I of the Amended Complaint asserting a claim for tortious interference is SUSTAINED, and Count I is DISMISSED WITH PREJUDICE;
2. Anthem's Demurrer to Count II of the Amended Complaint asserting a claim for unjust enrichment is SUSTAINED, and Count II is DISMISSED WITH PREJUDICE; and
3. Anthem's Demurrer to Count III of the Amended Complaint asserting a claim for quantum meruit is OVERRULED.

The Clerk shall send attested copies of this Order to counsel of record.




